Non-MEMBER RELEASE of LIABILITY & INDEMNITY AGREEMENT

In consideration for the Flagler Sports & Conservation Association, Inc. (hereinafter "Association") allowing me and any minor children identified below to enter its property as a non-member for the purpose of participating in or observing the activities that take place at the Flagler Gun & Archery Club (the "Activities"), I hereby release, discharge and agree to defend and hold harmless the Association, its agents, officer, directors, members and employees as well as other guests or non-members lawfully on the premises (the "Released Parties) from any and all liability, claims, rights, demands, and causes of action for personal injury, sickness or death, as well as property damage and expense, of any nature whatsoever, arising out of any contract, occurrence, event, act or omission ("Acts of Omissions") which may occur as a direct or indirect consequence of attendance at, participation in or observation of activities at the Association's property that may be made by me or any of my guests or family now or in the future, regardless of whether such acts or Omissions are reckless, negligent or intentional. This liability waiver is intended to be a complete and unconditional waiver of all potential causes of action against any of the Released Parties on behalf of me and any minor children identified below.

My signature below signifies that I have read, understood and agreed to the conditions of this Liability release & Indemnity Agreement and that I understand that participating in or observing shooting sports activities can be inherently dangerous at times and could result in severe injury or death. I agree to follow all posed rules and regulations as well as the instructions of the person(s) in charge of the particular range or activity while on Association property and agree to wear appropriate safety equipment to protect my eyes and hearing at all times that I am on or near an active range, whether I am participating in or observing range activities and to actively supervise and monitor the activities of any minors present in my custody.

I also understand that photographs may be taken by the Association or its members of activities, and I agree to be include in such photographs and give my consent to allow those photographs to be published in print or other media by the Association as it deems appropriate.
